GENERAL MEETING TUESDAY, AUGUST 29, 2017

The meeting convened at 8 p.m. with a moment of silence followed by the Serenity Prayer. Aaron K. (Yorkville) read the Twelve Traditions.

ADOPTION OF MINUTES – July 2017:

<u>Chairperson's Opening Remarks-</u> Roman R. (Stepping Stones), EC Chairperson:

Roman thanked everyone for attending this evening, and shared the following information:

At this point in the meeting, the members of the Executive Committee introduced themselves to those present.

There was a collection of the 7th Tradition, which totaled \$183.70.

FINANCE REPORT - Vanessa C. (Rox Glen Traditional), Finance Committee Chair:

<u>JULY 2017:</u> The approved Budget for 2017 anticipated Intergroup expenses to exceed Income by \$7,553 in the month of July. The Actual results show Intergroup expenses for the month of July exceeded income by \$4,720. We are ahead of the budgeted deficit of \$7,553 by \$2833. This favourable result for July 2017 is primarily due to operating expenses being lower than budgeted.

<u>JANUARY 1 to JULY 31, 2017</u>: For the first 7 months of 2017, Intergroup recorded an *Actual* Net Deficit of \$41,498 versus an anticipated *Budgeted* Deficit of \$53,567.

The ahead of budget results of \$12,069: (\$41,498) – (\$53,567), primarily reflect the following:

- higher than anticipated contributions \$4,109 and
- lower than anticipated operating expenses of \$5,738 and
- lower staff costs of \$4,023
- on a less positive note Net Literature Sales were off budget by \$3,967

Prudent Reserve: Target Prudent Reserve of \$ 287,787 vs. Actual Prudent Reserve of \$241,330.

Additional Comments from Vanessa/Questions from Floor members:

Gratitude Month: October is Gratitude Month. This is an initiative for members to donate to Intergroup so we can be fully self-supporting. Historically, donations come in from members in the months of October, November, and December. The Gratitude Flyers will be available for members next month at the Intergroup Meeting so they can take them back to their groups. We will include a little 'blurb' on Gratitude that you can share with your groups. Please start announcing this at your groups! In the past, there was the idea of cutting back on costs of the mailing for this initiative. We will again be doing the full mailing this year. It was found that members expect their Gratitude flyer in the mail to 'remind' them to mail in donations. Also, the mailing list is hard to 'cull'/check for duplicate listings due to lack of manpower. When you look at the numbers regarding individual contributions, they are coming in the month of October at about \$35,000. It's just not worth it for us to take that away; we like to know just how much donations are coming in by mail.

The Rep from Restoration and Recovery thanked the efforts of both the Finance Committee members and the Office Manager (Freda) for their efforts in keeping operating expenses in line. Vanessa replied "Thank you! We have great staff at the office and they are doing the best they can to make sure that—in terms of the finances – we are doing what we are supposed to be doing."

The Rep from St. Clement's Group inquired about the underspending on the salary line (see third line item above on year to date), and then asked if employee salaries will be reviewed this year for a more fair wage, and if not, would this happen for next year? Vanessa replied: "Part of the reason why it's a little bit lower than we had: we had a change of Office Manager, so that's part of the reason. There was even a period this year when there wasn't an Office Manager, so there was less hours. In terms of those kinds of issues, they can't really be dealt with at the full Intergroup level, as they are personnel issues. I appreciate that you bring that up, and it is important."

Finance Chair and Finance Committee Member Needed: Vanessa announced that she will be rotating out as Finance Chair as of January 2018. Ideally the committee would like to see a member join the committee sooner than later as they would have some experience as they rotate in to the position in January. The committee also needs an additional Finance member (one member has rotated out recently). Sobriety Requirement for both positions: 5 years of continuous sobriety, and some financial/business background is needed. *Please announce this at your groups!*

This committee meets on the 4th Thursday of every other month at 7:30 p.m. at 234. The committee is working on creating a Self-Support display board for the Intergroup Office. Self Support will be participating in both the upcoming District 22 Service Day (Sept.) and the Gratitude Roundup (Oct.). Zobie shared that the Self Support 'green cards' (regarding our 7th Tradition) are available for ordering in the Literature Department at 234. It's a great thing to read out at meetings to clarify our 7th Tradition. Zobie also mentioned about the Birthday Card envelopes, which are being discussed at the committee level. They are available through GSO (www.aa.org) which are a Self-Support initiative for members to show their gratitude by donating to GSO on their sobriety birthday. Zobie also mention that the *Daily Reflections* reading for July 26 is relevant to Self Support ("The Worth of Sobriety"). Next meeting: Thurs. The August meeting was deferred until September. Sue reported that service commitments are being met. **Next meeting:** Thurs. Sept.21 at 7:30 p.m. at 234.

TOYPAA (Toronto Ontario Young People in AA) -No report.

Next meeting: Sun. Sept.17 at 4 p.m. at 234.

RECEPTION – Bert J. (Silverbirch), EC Vice Chair:

Present this evening were 32 Group Reps, 6 Alternate Reps, 3 Districts, and 6 guests. Bert asked if some members could stay behind after the meeting to help clean up, empty the coffee urn, and put away chairs.

UNFINISHED BUSINESS from Previous Meetings: There was no Unfinished Business to discuss.

NEW BUSINESS:

Rychard B. (Mount Royal York), who serves a Twelfth Step Chair, approached the Floor with the following item: "So of you may not know, but we [on the Twelfth Step Committee] have had an Al-Anon representative on our committee. She simply serves as a liaison, because 40% of our crisis calls are actually Al-Anon people. We thought that, because of that statistic, that this would be a wise choice. Some concerns have been raised because she is not an alcoholic. Those are, of course, legitimate concerns to be raised. Our first reaction is "She *is* recovering from alcoholism, and she is using the 12 Step program. Alcohol has very little to do with alcoholism. But: it is our duty to follow up on this. So,

our committee phoned New York [GSO]. We asked them what they thought of this endeavour. Two things became very clear from this: 1. They were incredibly impressed with us that we were incorporating Al-Anon and making it part of AA, because Al-Anon is the *other side*; and 2. Each Intergroup is actually responsible for their own so they in New York can't actually say a 'yes' 'no'; a 'do' or a 'don't'. It is up to the group conscience to actually tell us whether you as members approve of it, or not. So we are here tonight, asking for a group conscience; to see if any member has a problem with this. That is, who is in favour of having an Al-Anon sit on the Twelfth Step Committee in a *non-voting* capacity, and that the Al-Anon does not work on a phone shift. The Al-Anon does attend the monthly phone training, however, and gives an Al-Anon 'point of view' to the trainees for informational purposes. The member from Al-Anon (Carla) has been an integral part of the Twelfth Step for the past year. I'm not sure how you would like to proceed with this, but we would like a group conscience on this."

Roman R. (EC Chair) shared the following for clarification purposes: "As an Executive Committee, we decided to exclude the Al-Anon person from being a member of the Twelfth Step Committee, simply because we wanted to keep Al-Anon separate from AA. It has been this way all along, and we would like to keep it that way. To be clear: we understood that the Al-Anon person was voting and participating in the [committee] meeting so, as a group we decided to exclude the member. I would like to continue this conversation with you, and perhaps bring it to the Floor, if need be. But I really think that this is not the forum to bring this issue. I'm not saying you're not entitled because you are, but there is a procedural thing in place...if you again bring it to us again at the EC, then we can bring it to the Floor correctly."

Rychard responded: "There is something I'd like to point out here: I got a phone call from Roman and he asked me 'Do you have an Al-Anon member?' and I answered 'Yes, we do.' Roman asked 'Is she a Liaison?' (Yes). 'Does she vote?' (No). He thanked me very much. He phoned me one week later and said that the EC had made a decision not to have an Al-Anon. The decision was made behind closed doors, with no notice and no representation, and I was told it was the group conscience. If there was a dialogue and we had a discussion about it, I wouldn't be standing up here now. This is group conscience; this is what New York [GSO] told us to do."

A long discussion ensued among Floor members. Roman asked for a clarity from Rychard on the question, which was done.

Motion moved by Mickey S. (Rep/High Park) that we table discussion on this item until next month. Motion seconded by Brenda (Alt. Rep/OISE). *Further discussion was held among the Floor*.

Result: There was a recommendation from several sources that we table this discussion until the next General Meeting, and Reps were asked to bring this item up at their groups for discussion. All were in agreement. This will be listed as a line item under Unfinished Business on the September General Meeting Agenda. Rychard shared that he was happy to stay after this meeting is adjourned to explain further and answer any questions that members had on this item. Roman also mentioned that he would like to be prepared for this dialogue by going through the EC minutes to find out specifics/exact details from their conversation, etc. so he can be better informed for next month's meeting for clarification purposes.

A member (Dean/Credit Valley) announced the following: **Mississauga Fall Roundup** will be held on **Saturday, September 30, 2017** at the Vic Johnston Community Centre – 335 Church St. Mississauga. AA and Al-Anon speakers. Tickets: \$20. Day includes hot and cold buffet lunch, morning snacks and all-day coffee/tea. *See website www.MississaugaFallRoundUp.org*.

<u>CLOSING REMARKS:</u> Roman again thanked everyone for attending this evening, and reiterated the following points:

- There is a <u>call for volunteers for Gratitude Month</u>. The office would really appreciate members who can come to 234 and label/stuff envelopes for mailing. Please contact our Office Manager, Freda at <u>office@aatoronto.org</u> if you can help us out.
- A new Finance Chair is needed very soon! We also need new Finance Committee members. 5 years of continuous sobriety and some finance/accounting/business background is helpful. Please announce at your groups.
- 1 or 2 new Executive Committee members are needed. Members of the EC must have a minimum of two years of sobriety. Please announce at your groups.
