THE ROLE OF THE INTERGROUP REPRESENTATIVE



- The Intergroup Representative is the voice for their group.
- As the Trusted Servant of their group, they have the right of decision to vote at the Intergroup General Monthly Meeting on behalf of their group.
- The Intergroup Representative participates in Intergroup General Monthly Meetings with other such Representatives to share their groups' experience in carrying the A.A. message.

THE ROLE OF THE INTERGROUP REPRESENTATIVE



- The Intergroup Representative keeps their Home Group well-informed about GTA Intergroup's activities.
- ✓ The Intergroup Representative obtains guidance from their Home Group about matter to be considered at the Intergroup General Monthly Meeting
- The Intergroup Representative can nominate a candidate for and/or stand for election to become a member on the Operating Committee.

INTERGROUP GENERAL MONTHLY MEETING VOTING PROCESS

- Motions are statements that describe a proposed action or decision.
- The process of making Motions ensures that no decision is accepted without the opportunity for discussion and a vote.
- An Intergroup Rep, Alternate Rep, and an Operating Committee Member have the right to bring a Motion forward on The Intergroup General Meeting.


TYPICALLY, THE MOTION MAKING PROCESS PROGRESS FOLL ST

- A member of the group proposes a Motion (the proposal):
 - Motions require that a second member of another group agrees to consider the proposal to ensure that the proposal is meaningful to more than one person.
- ii. A member of the group chooses to second: "Second" or "Ise and for discussion" if you want to be clear that you are not in support but want to entertain a conversation about the proposal.
 - Without a second the motion will die.
- Once the group has had a chance to speak in favor or against the motion, the Chairman will lead to a vote.

DETAILED STEPS OF A VOTING PROCESS

Member makes a clearly worded motion to take action or a position. Motions recorded in minutes Motion must be seconded. · A second allows discussion to occur, it does not signify approval. A motion without a second does not move forward. Chairman restates the motion. "It is moved and seconded that ..." Provides clarity Discussion/debate occurs. Maker of motion starts discussion Ammendments may be offered - return to step 1 to ammend motion; "I move to amend the motion by... Chair closes discussion and states the question/asks for a vote "The question is on the adoption of the motion that... · Motion repeated word-for-word Chairman provides voting directions: "Those in favor of the motion, say aye"; . "Those opposed, say no" Chairman announces the result of the vote: "The ayes have it, and the motion is adopted" or . The noes have it, the motion is lost." Recorded in minutes.

Operating Committee

Composed of ten persons:

- Chairperson and Vice Chairperson
- Treasurer (a.k.a. the Chair of the Finance Committee)
- Secretary
- Six Committee Members, (OC Liaison to a Subcommittee)
- OC Liaison are required to attend the Sub-Committee meeting that they are assigned to.
- The Chairperson shall be the Executive Officer of the Intergroup Office and shall perform such other duties as are incidental to this office.
- Responsible for the GTAI General Meeting, and attending the Joint Shared meeting

NEW BUSINESS

After the Workshop presentation, Marvyn stated the following:

- Every Motion presented on the Intergroup Floor has to have a 60% vote in favour, in order for the Motion to be passed;
- Only Intergroup Reps (or Alternate Reps in their absence) with a '1' indicated beside their name on the Zoom participants list have a vote tonight

Marvyn then asked Eric S., Welcome Group Rep, to address those present:

Motion by Eric S. (Welcome) to reconvene Intergroup [General] Meetings, starting in April 2023, to Timothy Eaton Church, 230 St. Clair Avenue West, Toronto. The meeting would be a hybrid of in-person and Zoom attendance. Eric continued: "If the Motion doesn't pass, then it would remain as a Zoom meeting." Motion seconded by Angela O. (Mount Royal-York).

Eric was given the opportunity to address his group's Motion: "Originally the Motion was going to be done as three choices; a lot of Intergroup Reps took this back to their groups. Due to the fact that we need a 60% in favour voting result, we thought that having three choices might divide the vote and this would always remain a Zoom-only meeting. This has some merit; however, the fellowship aspect to having meetings in person is missing. When the pandemic had passed and groups went back to in-person meetings, some groups like Welcome still provided a hybrid format for Speaker meetings. So this was the rationale behind presenting this Motion in its current structure."

Further to the Motion, Marvyn suggested looking to May 2023 as a start date – if the above Motion passes – in order to prepare for the hybrid meeting in terms of technology needed (IT Subcommittee input) and appropriate planning. There were no objections from the Floor.

A discussion ensued among Floor members, and questions/concerns were addressed.

Motion to vote on the above Motion tonight moved by Ted D. (Rox Glen) and seconded by Christopher S. (Long Branch). Carried.

Results: 18 votes for the motion; 9 votes against the Motion; 2 abstentions noted. TOTAL REPS VOTING: 29. **MOTION PASSED.**

Marvyn asked if anyone from the Voice of the Minority (those groups who voted against the Motion) wanted to address the Floor.

Brendan O. (FOTS): "I think we're putting the cart before the horse; we don't know if the church will take us; we don't know the details of what it will take to implement a hybrid meeting; we don't know what it will cost...shouldn't we put that together before we make a decision? We have no information."

Marvyn: "The church got back to us in February [in the affirmative] so we know that's a possibility. We haven't talked to them in the last month but I'm sure they will honour our intentions. Yes; you are correct about the tech information, which is why we are having Michael W. (Welcome) IT Subcommittee Chair at our April meeting to give a report to the Floor and clarify the tech side of this initiative.

Cam B. (Deer Park), Finance Chair, added: "Brandon I do understand what you're saying; I also want to say that the Operating Committee has been discussing this initiative for quite some time. There were opinions on both sides shared at that time. In order to do this, we thought that we needed an Intergroup Rep to come forward and propose this idea and 'lead us' in the direction of investigation [of the hybrid possibility]. If we didn't have that proposal – and we didn't have Reps wanting to do this initiative— then why would the IT Subcommittee start putting resources into it? By having this Motion accepted tonight, NOW we can begin that process. If – for whatever reason – this idea is impossible, then this fact will be reported to the Floor."

Brendan: "My question is – if there are logistical problems and costs involved...once we've already voted that we're doing this, does that mean we're going to spend whatever it takes to do this? Cam: "Absolutely not. It has to be investigated and determined to be feasible."

Brendan: "Not to be pedantic, but that wasn't what the Motion was about; to investigate. The Motion was 'we are doing this next month' and we need to change that Motion to [state] May [as the starting date]..."

Marvyn: "I feel we stay the course and try to do the best we can."

Mike C. (Beverly Hills): "Last weekend we had the ORC. One of my group members attended the event and he didn't wear a mask. I asked him how many people attended that were wearing masks; he said 4 or 5 people. So, 4 or 5 people out of the entire ORC attendance is a very small number. So, if we are going to have a hybrid meeting, who is going to be wearing masks at the Timothy Eaton Church? Everyone? Are there going to be anti-vaxxers there? I won't come to an in-person meeting [due to health concerns]..."

Marvyn: "All I can say is that we have a personal choice whether to wear masks or not wear masks. We have to leave it up to the alcoholic; the member themselves to make that choice. If they don't feel comfortable at an in-person meeting, they have the hybrid option."

Marvyn added that there will be a report on the planning of the hybrid-format General Meeting implementation from the IT Subcommittee at the April General Meeting. We also need to check on room availability at the Timothy Eaton Church. In light of this, we hope to have this new General Meeting format in place by the May General Meeting (Tues. May 30, 2023).

CHAIRPERSON'S CLOSING REMARKS

Marvyn thanked everyone for their patience, participation and dedication to service.

A Motion to adjourn was moved by John C. (Pine Hills) and seconded by Christian H. (Tuesday Men's). Carried. The meeting adjourned with the Responsibility Declaration.
