#### CHAIRPERSON'S OPENING REMARKS – Jomana A. (Stepping Stones), Operating Committee Chair

It's really exciting to see 19 members present at the in-person portion of this meeting! We have 41 members online tonight. It's great to see so much participation.

The current Operating Committee members are already two months into their positions. We have been familiarizing ourselves with our service roles; also securing our logins and credentials needed. I've had the opportunity to meet almost all of the Subcommittee Chairpersons, and am grateful to have been invited to their subsequent monthly subcommittee meetings. We are experiencing a wonderful cooperation between Intergroup and the service districts to facilitate carrying the message to the still-suffering alcoholic.

At this point in the meeting, Jomana asked Operating Committee Members to introduce themselves to the Floor.

Contributions for January are within \$100 of budget while Literature Sales are 8% higher than budgeted, giving total revenues of \$20,764. Note that \$12,260 Lit. Sales is net after the 20% discount was applied as per the 2024 budget.

Cost of Goods Sold is 16% higher than expected due to lower exchange rates and higher than expected shipping costs. However Expenses were 23% lower than budgeted giving an overall deficiency of \$2,691 better than budgeted.


#### **Motion from the Floor**

Bryan W., Rox Glen Traditional Group (who was attending in person), approached the microphone and asked the OC secretary to screen share a particular website to attendees, in aide of the Motion his group was presenting this evening (see below).


Bryan shared: "A quick little history: I'm a founding member of my Home Group; I've been sober over 30 years. I served on the Public Information Subcommittee for more than 5 years."

[Referring to the website currently screen shared] "I came upon this website purely by accident. I typed in 'AA Toronto' [Google.ca] and this particular website popped up:





[When you click on the Your Support Services Network https://yssn.ca/alcoholics-anonymous-aa-greater-toronto-area-intergroup/ the following site pops up]:



"I clicked on the link. I was looking for Intergroup. I was shocked. This site isn't Intergroup, and it's not AA. As a long-time member, I was very disappointed when I saw this because it's aligned with all these agencies. In AA, we don't do that; we don't do what all these other agencies listed [on this site] do. For the newcomer that wants to look up AA and check out what A.A. is all about [by clicking on this link] they could think 'oh A.A. does this and AA does that'. There is a button at the top that says 'What We Do'. When you click that button, you get a list of all these options...but we [A.A.] don't do them. This is extremely misleading. Another button says 'Who We Are'. We are not these different agencies; we are Alcoholics Anonymous. We do one thing and one thing only: we help the alcoholic that still suffers."

"I'm going to read you the Tradition that speaks to this. Tradition Six: 'A.A. ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose' which is helping the still-suffering alcoholic. I'm going to quote the last paragraph of that Tradition [Twelve Steps and Twelve Traditions, page 159]: 'Concerning endorsements, our dear friend said it all. We saw as never before we could not lend the A.A. name to any other cause other than our own.' This is extremely important."

"I understand that we can't approach this group and ask them to take this [our listing] down; therefore..."

Motion to have the GTAI Operating Committee request an audience with the Executive of Y.S.S.N. [Your Support Services Network] and ask – not demand – that this group of people take this thing [A.A. Toronto Intergroup listing] down moved by Bryan W. (Rox Glen Traditional) and seconded by Richard M. (Pine Hills).

Jomana then asked OC Secretary, Kelly L., to retrace Bryan's steps on the Internet and screen share for all to see (see above screen shots).

Once the site was up and screen shared to all, Jomana shared: "The reason that Alcoholics Anonymous Greater Toronto Area [A.A.] is mentioned on this website is as a resource for people who are struggling with alcoholism and addictions.

The 'buttons' [What We Do] is referring to the Y.S.S.N.; they are talking about themselves and not Toronto Intergroup. I just want to make sure that I'm understanding your group's Motion. They are mentioning us as a resource, which would be completely legitimate. We have [tape unclear] mentioning us as a resource for help with alcoholism and addiction. So this website is not pretending to be A.A. Intergroup; and it's also quite clear so as not to confuse people to think that this is A.A. Intergroup." Brian still felt that it is very misleading.

Jomana mentioned that it is currently 9:15 p.m.; she wanted to get a sense of the Floor as to whether to continue discussion tonight, or defer this Motion until the March General Meeting.

A sense of the Floor/show of hands was taken at this time. **Discussion/Vote on Motion deferred until the March 26, 2024 General Meeting.** 

**CHAIRPERSON'S CLOSING REMARKS:** Jomana thanked everyone for their participation and dedication to service; adding: "Come and find me at the ORC!"

Motion to adjourn moved by Mitch G. (River Drive Park) and seconded by Ted D. (Rox Glen Traditional). Motion carried.

The meeting adjourned with the Responsibility Declaration.

NEXT GENERAL MEETING: A hybrid meeting will be held on Tuesday, March 26, 2024 at 8 p.m.

# ONE OC MEMBER NEEDED!

SERVING ON THE GTAI OPERATING COMMITTEE: WHAT'S INVOLVED?



## The Operating Committee ('OC') is composed of ten persons:

- Chairperson and Vice Chairperson
- Treasurer (a.k.a. the Chair of the Finance Committee)
- Secretary
- Six committee members, (will be assigned the role of OC Liaison to a Subcommittee)

## **Qualifications of Members of the Operating Committee**

- Members of the EC must have a minimum of two years of sobriety.
- Experience in various service positions within one's home group and in General Service are helpful.
- Helpful to be familiar with GTAl's <u>Operating Procedures and Guidelines</u> manual in tandem with Twelve Steps and Twelve Concepts.

## Terms of Office for Members of the Operating Committee

- Members of the OC are nominated and elected as necessary when vacancies occur. They are elected by the voting members of the Intergroup Floor from the total membership of Alcoholics Anonymous in the Greater Toronto Area, including serving Intergroup Reps and/or Alternate Reps.
- The term for a member of the OC is one year; this term may be renewed annually, for up to 2 more years, to a maximum of 3 continuous years.
- Term for OC Chair and OC Vice-Chair is 2 years for each position.
- If an OC member is elected as Vice Chair or Chair, the maximum term for continuous service on the OC may be extended for the terms of those positions only, to a maximum of 6 years.
- At the end of their term of office, members of the OC are ineligible to serve on the OC for a period of 24 months.

## Monthly Responsibilities as an OC Member

- Attends the monthly OC Meeting (held on the Wednesday <u>before</u> the monthly General Meeting Currently meeting online at 8:00 p.m.)
- Attends one monthly (or bi-monthly) subcommittee meeting, as part of OC Liaison duties
- Attends of monthly General Meeting (last Tuesday of each month at 8 p.m. Currently meeting online)
- All members of the OC may attend meetings of the Finance Subcommittee. Only the Chairperson of the OC may have a voice and a formal vote at the meetings.
- Attend the quarterly meetings held with District Reps ('Joint Sharing Meeting') where members of each service level share information about current activities

## Monthly Responsibilities as an OC Liaison to GTAI Subcommittees

- Attends monthly meetings of subcommittee(s) as an assigned OC Liaison in a non-voting capacity unless requested by the subcommittee to take an active part in its operations.
- Observe activities of subcommittee
- Report on committee's activities

- Prepare a brief (point-form) written Liaison report for the monthly OC meetings
- The Intergroup Liaison for a committee may be required, in the absence of the Committee Chair, to present the committee report about committee activities at the General Intergroup General Monthly meeting and take questions back to the committee to be answered at a later meeting.

## FAQ ABOUT SERVING ON THE OPERATING COMMITTEE

## Q: What is GTA Intergroup's Mission?

**A:** Greater Toronto Area Intergroup is a coordinating body that supports the 12-step work of AA groups in the Toronto area, providing a point of contact between individual groups, our members, the public and the still suffering alcoholic.

# Q: Can I still serve as the Intergroup Rep. for my Home Group and serve on the Operating Committee?

A: No. If you are elected to the Operating Committee, you must resign as your Intergroup Rep.

## Q: What are some of the attributes that may be desirable for those considering this position?

**A:** As our Second Tradition states -- our leaders are but trusted servants; they do not govern. The Operating Committee does not govern, but it is in a position of authority in its recommendations and decision-making on behalf of Greater Toronto Area Intergroup.

Those considering serving on this committee may on occasion deal with sensitive and contentious issues. Maturity, attention to detail, discretion and dedication to the good of the organization are desired.

## Q: As a Committee member, would I be personally liable in the event of bankruptcy/lawsuits?

**A**: No. As a charitable organization, AA Greater Toronto Area Intergroup has insurance coverage for committee members.

## Q: Who can I talk to about serving on the Operating Committee?

**A**: You may speak with anyone on the Operating Committee or former Operating Committee members for further information. You may be nominated to serve, or you can nominate yourself.

The role of Chair for the ORC is a 3-year service commitment – one year as Shadow Chair, one year as Chair, and one year as Member without Portfolio.
