Marvyn shared the following:

- November has been a busy month! A lot of initiatives have been accomplished;
- For the last two years, our Twelfth Step Committee has done a fantastic job!
- While the Twelfth Step Committee's commitment and dedication have served the still-suffering alcoholic and the general membership well (especially through the pandemic!), there is a concern about 12 Step Calls and the fact that these have dramatically diminished (only 75 12 Step Calls were achieved this year). We are looking at creative ways to implement 12 Step Calls to increase outreach numbers.

(Stepping Stones), 2024 Incoming GTAI Operating Committee Chair, to inform Floor members of the following: **As of January 30, 2024, we are pleased to announce that the monthly GTAI General Meeting will commence the in-person/hybrid meeting model!** For those who want to attend in person, the meeting will be held at Timothy Eaton Church (St. Clair Avenue West at Dunvegan) upstairs. For those who wish to attend the monthly General Meeting virtually, they can do so. #### ARCHIVES: Glenn G. (East York), Chairperson

I am an alcoholic, a member of the East York group, having the honour, privilege and responsibility to serve as the GTAI Archives Committee Chair; my name is Glenn.

Work, this year, at the Archives Committee has been busy, informative and entertaining. Here's an update since my last report. Both Eddy G., GTAI Archivist and David T., assistant Archivist have been attending group and long timer medallions with the GTAI Archives display. They have recorded the meetings in most instances as well. Additionally, they have been busy in the Archives repository in the Intergroup offices; sorting through donations, documents and artifacts. They also sanitize meeting minutes by removing last names and update our database. They are a couple of workhorses and the committee is grateful for their activity, knowledge and enthusiasm! Our District Archives committee chairs, along with other GTAI Archives committee members, have also been actively gathering both oral and group histories. The Area 83 Eastern Ontario International Archives committee chair, Jenny C., has interviewed two former Area 83 Delegates!

In October, the Area 83 Service Information Day committee, as part of the Area 83 Eastern Ontario International Assembly weekend held in Kingston Ontario, invited Eddy and David to present the history of Area 83 as one of the sessions. Mari G., of the Markham Third Tradition Group, spoke and intertwined AA history into both the serious and humorous parts of both her story and the disease of alcoholism. 180 members attended the sold out breakfast. It must be submitted directly to this email address (bettertimes@aatoronto.org) or alice@aatoronto.org. If you submit your content after the 10th, I will confirm via email whether we can accommodate your submission. This is because content plans are usually put together by the 12th of every month.
- 2. Please submit all content (group announcements, flyers, medallions, etc. etc.)

  to <a href="mailto:bettertimes@aatoronto.org">bettertimes@aatoronto.org</a> or <a href="mailto:alice@aatoronto.org">alice@aatoronto.org</a>. You may cc Luke if you wish, but <a href="mailto:please ensure">please ensure</a>

  that <a href="mailto:bettertimes@aatoronto.org">bettertimes@aatoronto.org</a> or <a href="mailto:alice@aatoronto.org">alice@aatoronto.org</a> is included in all content submissions. There has been an increasing number of instances in which content is only submitted to Luke, and this is creating unnecessary uncertainty over newsletter space allocation. We need to nip this in the bud.
- 3. Article submissions should not exceed a maximum count of 600 words. We've found that 600 words is more than enough to convey a message, and it can often still be trimmed down. If you feel uncertain of the amount of details to share in your piece, I'd suggest the inverted pyramid style of writing. This writing style ensures that the most important information is placed at the top of the article.
- 4. All articles or illustrations submitted to Better Times may be subject to editing. Please understand that from a panoramic point of view, editing articles involves a delicate balance of the key message(s) within an article, the voice of the author, grammatical fixes, editorial standards of the publication and making the most of very limited space. As a result, I conduct and/or oversee all editing. Sincere effort is, and will continue to be made, to ensure that authors are notified of any substantive editing actions.

In conclusion, please help us spread the word to other GTA AAers that Better Times is actively seeking content submissions. Submissions can be in the form of articles, cartoons, illustrations, etc. You can view a list of topics on this page.

Things have been picking up speed in the Twelfth Step Committee lately and the momentum has ramped up. Lots of cross pollination with other sub-committees, especially communications, accessibility. We continue to be swamped by requests to do the phones, but we are also hearing from people who want to be a Twelfth Step caller. Unfortunately, still not finding anybody who wants to do overnights, which is kind of weird given who we are and what we used to do on a regular basis. We really don't want to terminate our longstanding status as a 24/7/365 and are hoping for a miracle. It's really too bad because with as few as 20 more people, we could shorten the commitment from seven days to three and/or four, possibly even two. Please put that in your God bag or prayer box or whatever you use when you need a miracle. As for the Twelfth Step caller, it's the ultimate Service commitment given how our program works, one alcoholic sharing with another, yet you may never have to answer the call more often than every four to six weeks. To have at least one 12 Stepper for every language spoken in this city would be downright amazing, and it should be doable. Who can't spare an hour every six weeks to pay it forward?

So to this end, we have blown up the ancient Twelfth Caller list and 'McGyvered' a new look and feel. Typically this group of people is made up of 90 individuals working in isolation, so we have reached out to them in an effort to bring them into the fold and into this century. It's early in the initiative, but we have established rapport with many of them such that they are making suggestions and becoming more engaged. And finally, we have found a solution to the call display issue so that they no longer have to miss a call because the number was unfamiliar. And then we are going to do the same with all the other areas that make sense—like having similar lists for Meetings to Go and Bridging the Gap. So if like my home group you have a fairly large contingent of young, eager, energetic members, please fire them up to join the Twelfth Step Committee or take on a phone shift or two. Their recovery won't know what hit them.

## THREE OC MEMBERS NEEDED!

SERVING ON THE GTAI OPERATING COMMITTEE: WHAT'S INVOLVED?



## The Operating Committee ('OC') is composed of ten persons:

- Chairperson and Vice Chairperson
- Treasurer (a.k.a. the Chair of the Finance Committee)
- Secretary
- Six committee members, (will be assigned the role of OC Liaison to a Subcommittee)

## **Qualifications of Members of the Operating Committee**

- Members of the EC must have a minimum of two years of sobriety.
- Experience in various service positions within one's home group and in General Service are helpful.
- Helpful to be familiar with GTAI's <u>Operating Procedures and Guidelines</u> manual in tandem with Twelve Steps and Twelve Concepts.

## Terms of Office for Members of the Operating Committee

- Members of the OC are nominated and elected as necessary when vacancies occur. They are elected by the voting members of the Intergroup Floor from the total membership of Alcoholics Anonymous in the Greater Toronto Area, including serving Intergroup Reps and/or Alternate Reps.
- The term for a member of the OC is one year; this term may be renewed annually, for up to 2 more years, to a maximum of 3 continuous years.
- Term for OC Chair and OC Vice-Chair is 2 years for each position.
- If an OC member is elected as Vice Chair or Chair, the maximum term for continuous service on the OC may be extended for the terms of those positions only, to a maximum of 6 years.
- At the end of their term of office, members of the OC are ineligible to serve on the OC for a period of 24 months.

## Monthly Responsibilities as an OC Member

- Attends the monthly OC Meeting (held on the Wednesday <u>before</u> the monthly General Meeting Currently meeting online at 8:00 p.m.)
- Attends one monthly (or bi-monthly) subcommittee meeting, as part of OC Liaison duties
- Attends of monthly General Meeting (last Tuesday of each month at 8 p.m. Currently meeting online)
- All members of the OC may attend meetings of the Finance Subcommittee. Only the Chairperson of the OC may have a voice and a formal vote at the meetings.
- Attend the quarterly meetings held with District Reps ('Joint Sharing Meeting') where members of each service level share information about current activities

## Monthly Responsibilities as an OC Liaison to GTAI Subcommittees

- Attends monthly meetings of subcommittee(s) as an assigned OC Liaison in a non-voting capacity unless requested by the subcommittee to take an active part in its operations.
- Observe activities of subcommittee

- Report on committee's activities
- Prepare a brief (point-form) written Liaison report for the monthly OC meetings
- The Intergroup Liaison for a committee may be required, in the absence of the Committee Chair, to present the committee report about committee activities at the General Intergroup General Monthly meeting and take questions back to the committee to be answered at a later meeting.

## FAQ ABOUT SERVING ON THE OPERATING COMMITTEE

## Q: What is GTA Intergroup's Mission?

**A:** Greater Toronto Area Intergroup is a coordinating body that supports the 12-step work of AA groups in the Toronto area, providing a point of contact between individual groups, our members, the public and the still suffering alcoholic.

# Q: Can I still serve as the Intergroup Rep. for my Home Group and serve on the Operating Committee?

A: No. If you are elected to the Operating Committee, you must resign as your Intergroup Rep.

## Q: What are some of the attributes that may be desirable for those considering this position?

**A:** As our Second Tradition states -- our leaders are but trusted servants; they do not govern. The Operating Committee does not govern, but it is in a position of authority in its recommendations and decision-making on behalf of Greater Toronto Area Intergroup.

Those considering serving on this committee may on occasion deal with sensitive and contentious issues. Maturity, attention to detail, discretion and dedication to the good of the organization are desired.

## Q: As a Committee member, would I be personally liable in the event of bankruptcy/lawsuits?

**A**: No. As a charitable organization, AA Greater Toronto Area Intergroup has insurance coverage for committee members.

## Q: Who can I talk to about serving on the Operating Committee?

**A**: You may speak with anyone on the Operating Committee or former Operating Committee members for further information. You may be nominated to serve, or you can nominate yourself.
