Motion to Suspend Regular Business: Elections for new 4 Operating Committee Members

Motion moved by Lori C. (Friendly) and seconded by Beth B. (Fellowship). Motion carried. (7 for in person; 26 for/1 against virtual)

Jomana invited current Operating Committee member, Lijon G. (Love & Tolerance) to share his experience with serving on the Operating Committee.

After this, Jomana outlined the qualifications and service commitments for this position [See OC members' roles and responsibilities document/page 3 of these minutes] and asked if any there were any nominations/volunteers from the Floor.

David L. (See To It) volunteered to serve on the Operating Committee. Jomana asked David to share his recovery/service journey to Floor members. David shared that he will have 2 years of continuous sobriety in July. With the understanding that 2 years of sobriety is needed for this service position, Jomana asked for a sense of the Floor and/or Vote to accept David as an OC member at this time.

Vote to accept David L. (See To It) as a new OC member: 7 for in person; 20 for/1 against/2 abstentions virtual. David L. is accepted and acclaimed as a new member of the Operating Committee.

An election for 3 OC members will be held at the March General Meeting. Please announce to your group members!

Both Contributions and Literature sales are better than 2024 by 22% and 45% respectively. Literature sales do not have a 20% discount for 2025, this explains the 45% difference between 2024 and 2025.

Cost of Goods Sold is 8% lower than last year while Expenses are slightly higher. Overall there was a surplus of \$2,980 for the month compared to a loss of \$3261 for 2024.

There is no comparison to the 2025 Budget as it has not been approved at this time.

The 2025 Budget Proposal continues the 20% literature discount implemented in 2024. As a result, literature income for 2025 is budgeted at \$26k, an increase of \$1k from 2024. Total budgeted revenue for 2025 is \$181k comparable to last year.

Committee expenses are up slightly; however, this is more than offset by a reduction in operating expenses. Staff expenses have also gone up slightly. Net result is that Total Operating and Staff expenses for 2025 are comparable with 2024. Budgeted deficit for 2025 is \$34k.

Committee expenses have been budgeted high, this is to encourage committees to support initiatives to carry the message. Intergroup has made the funds available, please put it to use.

For 2024 there was a budgeted deficit of \$33,700 and actual deficit of \$36,142. The Prudent Reserve at the end of 2024 is \$331,000, growth is strictly interest accrued, Intergroup will not be making a deposit for 2024. Prudent reserve target for 2025 is \$288,000. Finance committee is recommending that the reserve remain in place at RBC until it matures in March 2026, funds can be transferred to the general account at that time.

After the presentation, Bruce shared the following:

"There was a question earlier in this meeting about the Prudent Reserve. For 2024, we did forecast the deficit was to be \$33,700. It actually came in at \$36,142 (though we had a few extra expenses in there that we didn't foresee). It's not a bad thing. Our Prudent Reserve amount at the end of 2024 was \$331,000. This amount has gone up just by the interest; it's in

a bond (a GIC). Whatever money that was made on that was made through interest alone. There has been no increase to the Prudent Reserve; had we broken even or made a profit in 2024, that \$36,142 that I'm showing as a deficit would have been added to our Prudent Reserve. It's not, because we don't have it. The decision was made to not take any money out of the Prudent Reserve at this point. The bond matures in March of 2026, so we decided to just let it 'ride itself out' and when it matures we can flip it over. It's a bit easier. As it stands basically just a matter of moving money from one bank account to another. It's not a really big deal. If we need to do it, we need to do it. Our day-to-day operating account is in very good shape currently so moving money into it [Prudent Reserve] doesn't really do anything. That I hope explains our Prudent Reserve. So, next year we are looking to run at another deficit of around \$34,000. Between 2024 and 2025 we're nearly \$70,000 so we will take that straight out of the Prudent Reserve at the end of this year or early 2026."

Motion to accept GTA Intergroup 2025 Proposed Budget as presented moved by Kathy F. (Sisters in Sobriety) and seconded by Dee G. (Steps to Serenity). **Motion carried.** (6 for Motion in person; 15 for Motion/1 against/0 abstentions virtual)

- Still experiencing inconsistencies for clearance to volunteer in institutions
- We will have a Corrections display at the ORC; Anthony C. (D10 CF Chair) will spearhead this activity

CPC/PI: No Report.

GRAPEVINE: Imran R. (Port Credit), D06 Grapevine Chair

The meeting was held on Feb. 16; 4 members were in attendance.

Introduction – Who are we as the Intergroup-District Grapevine Committee?

Imran R invited Huguette B, Area 83 Grapevine Representative, to our committee meeting. Imran shared that when he joined the committee a year and a half ago, it was inactive, but a fellow member from District 6 encouraged him to revive it. Two years ago, there was no Grapevine rep at the Winter Season Open House, which highlighted the need for this meeting. Since then, we've had consistent participation from at least three districts. Our meetings are held on the third Sunday of each month for 30 minutes, with no formal structure but roles filled as needed. The upcoming ORC event in March will be a focus. Our intergroup budget is \$1,000 annually, mainly spent on sending subscriptions to correctional institutions and purchasing back issues for events.

Old Business - Previous Action Items

- 1. **Updating the GSO Grapevine Brochure:** The brochure is outdated; lacking mention of the podcast, app, YouTube, and website. Huguette suggested waiting for PCAS to review the agenda before addressing updates, which will be brought up at a future meeting.
- 2. **Intergroup Storage Space for Minutes:** This task has not been completed due to the absence of an IT Chair. Huguette suggested asking David T., The Area Archivist, to assist. Imran and Huguette will email each other to outline goals for archiving Grapevine minutes. Huguette will meet with David at the Kingston Assembly.

District-Specific Updates and Initiatives

- Ontario Regional Conference (ORC): Imran will request 100 Grapevine issues for the ORC. Handing out books at past events has been effective and will continue. Gigget will attend the ORC and assist at the table.
- **District 2:** Mariam M. has rotated out of previous roles and will continue as the Grapevine rep for the next term. She is balancing her service responsibilities.
- **District 6:** Imran reported that his new poster boards were a success; though updating them will be limited. He was very grateful for the help he had from a friend to finish all three boards.
- **District 14:** Gigget W. has provided the King City Group with a Grapevine board and back issues. There have been no changes to the number of Grapevine reps in her district. Canada Post seems to have caught up on deliveries. Gigget attended the Service Information Day workshop with Huguette the day before and will share the video links she shared with her district.

Updates from Area 83: Huguette B thanked the committee for the introductions. She acknowledged the multiple service positions held within districts and the decline in Grapevine reps in her area. She suggested considering bi-monthly meetings after PCAS and ORC to avoid burnout. Huguette also mentioned a possible collaboration with Intergroup Ottawa in the future.

Discussion on Future Initiatives: Huguette asked about working with Treatment Chairs at the district and Intergroup levels, noting that not all districts have Treatment Chairs. Imran will follow up on the vacant Intergroup Treatment Chair position at the next general meeting. This initiative will be revisited next month.


