July 2021

- The deficit of \$108 was just below the budget of \$1.2 K
- Contributions were 2.0 K or 15% below the budgeted amount of 13.1 K and literature sales were very low at only 4.0 K or 40% below budget
- Total revenues of 15.1 K were 4.7 K or 24% below budget
- Expenses were 1.3 K below budget caused by committee, operating and staff expenses were all lower than budget

July 2021 YTD

- The deficit of 4.3 K compares favorably to the budgeted deficit of 20.4 K
- Due to the lower than budget contributions in June and July we are now 1.3 K below our July YTD plan
- Literature sales are 3.6 K or 8 % below budget, the literature sales budget is 50% of the 2020 budget due to the pandemic. Literature have started to improve in August and for groups meeting in-person now is a great time for groups to stock or restock your libraries. Helen will be on vacation for 2 weeks from the 5th to the 15th of October and we encourage you to place orders in September including medallion engraving wherever possible
- Total revenues of 112.2 K were 5.0 K or 4% below budget
- Expenses are 15.3 K or 14% below budget for the following reasons: <u>staff expenses</u>: a combination of wage subsidy and lower than budgeted bookkeeping costs totaling 8.7 K, <u>committee expenses</u> lower by 3.7 K and lower <u>operating costs</u> mainly printing and phones. Year-to-date there have been only \$ in committee expenses
- Finally, Helen, Alexx and the Finance and IT Committee, have been working to prepare for the upcoming October Gratitude Month campaign. Intergroup relies on contributions from individual members and groups to sustain its operations and pay its bills.
- This year like last year we will be mailing and emailing Gratitude Month flyers to encourage contributions at this time of year. I will have more to say about Gratitude Month at the September General Meeting.

TWELFTH STEP: Laura V. (Mount Royal-York), Chairperson

The two most commonly asked questions are "Can you help me get a sponsor?" and "How do I sign up/register for the course?"

We would like to find out if the membership at large has any appetite for having a pool of temporary sponsors either on the website or accessible through the Help Line, much like the 12 Step Callers List. Intergroup reps could poll their membership and have anyone interested in being on the Master Temporary Sponsor list email 12step@aatoronto.org and provide their name, group, cell number, postal code and perhaps age although I'll leave that to your discretion. We would try as much as possible to match callers up with sponsors in the same part of the city.

Newcomer Guides for Newer-comers

Because there is no service commitment available to brand new members (no ashtrays to clean or chairs to set up), we'd like to compile a list similar to the 12 Step Caller List whereby members with as little as a week of sobriety would contact a brand new newcomer and offer to take them to Zoom meetings for a week. Given they're both ostensibly doing 90 in 90, this will allow the Guide to feel useful, the newbie will feel somewhat safe, with the possibility of establishing lifelong connections. We would need their name, cell number and postal code so that if they wanted to meet for a coffee, and/or whenever in-person meetings resume, they would be able to hang out with relative ease. The hope is that each of them would then bring others into their midst, like I did in days of yore when five of us in our first month went to the same meeting every night of the week and held each other accountable if anyone didn't show up (plus we were doing ashtrays at our home group). My best friend of over 37 years in recovery was in that original 'fivesome', and we still attend meetings together via Zoom and speak on the phone practically every day, usually about practicing the principles in the latest challenging life event.

Finally, at our next committee meeting, we will begin addressing "spirit of rotation" in preparation for replacing me next summer. If anybody knows someone with above average computer skills who might be interested in the position, please let me know as I'd like to start breaking them in ASAP. I'm not in any hurry to leave, but I think we all know how difficult it is to fill these spots.

Maybe we should have a symposium on Volunteerism in AA and explore why those of us who reap the rewards of doing Service consistently fail to inspire the herd. Yours in Love and Service, Laura V.

Eddie shared that he is in the process of putting together a WSOH committee, and has reached out to former committee volunteers for this effort. Gord H. (Bloordale), Operating Committee member, has gratefully volunteered to liaise this year. Eddie has started reaching out to previous locations of the event. He reported that the event cannot be held at St. James Cathedral Centre – Snell Hall – 65 Church St., Toronto (2017 location) and he is also trying to reach out to College Street United Church, 452 College Street, Toronto (corner of College Street and Bathurst) where the 2019 Event was held. Response from that facility is still pending. Gord H. has committed to reaching out to the Bloordale United Church for the possibility of using their facility.

CORRECTIONAL FACILITIES: Máire O'B., Toronto Inter-District Corrections Chair

Corrections has been fairly quiet for the last month. The Ontario Corrections Institute is not yet re-opened. The Toronto South Detention Centre and the Toronto East Detention Centre are still not allowing volunteers in. There have been no Bridging the Gap requests. We are continuing to finesse our PowerPoint presentation for Probation and Parole offices in the GTA. We expect to get this rolling in October. We have finessed the Pen Pal Workbook. We can now approach the institutions here in the GTA and perhaps the Area to see how and when we can get this operational.

Bridging the Gap

The Bridging the Gap Program, or BTG, connects the new member being discharged from a facility to A.A. in their community. You are being asked to be that connection, what is called a Temporary Contact. When a new, soon-to-be discharged member contacts us, we match that person to a Temporary Contact in the community where they will be living.

If you have volunteered for this type of service, we will call you, get the okay and then send you their contact information. Your job is simple. You contact the new A.A. member and arrange to take them to an A.A. meeting, preferably within 24-48 hours of their discharge. Your commitment is taking them to as many as six meetings.

During this time, you help them become acquainted, get phone numbers and perhaps locate a sponsor and a home group. You introduce them to others in A.A. so they have a broad, healthy base, then you are available to serve as a Temporary Contact for another person. Yours in love and service, Máire

There will also be a new book available as of September 3rd. It's called Prayer & Meditation where AA members share the many ways they connect spiritually.


